And represented by **Prof. Gauri Milind Rane** which expression shall mean and include its successor in office and assigns.

ABC Trainings, CADD Centre, The party of the first part shall provide:

The College, The party of the second part shall provide:

- Disciplinary supports for the smooth conduct the session.

Time Scheduled:

The program will be conducted during the college timings. Depending on the total strength, The programs will be conducted according to the time table drawn up with the mutual consent of the both parties.

Jurisdiction:

All matters, Queries, Dispute or differences, whatsoever, arising between the parties touching the construction, meaning, operation or effect of this Memorandum of Understanding or out of or relating to this Memorandum of Understanding or breach there of shall be settled through arbitration in accordance with the relevant Arbitration Act in force at such time. The Arbitration award shall be binding on both parties.

Termination:

Both the college and CADD centre shall have the rights to terminate this MOU by providing three months notice. Termination of this MOU for whatever reason shall be without prejudice to the rights of either party and the students and ongoing academic programmes.

Validity:

This Memorandum of Understanding will be valid for a period of Three years. This Memorandum of Understanding shall come into effect from 02/02/2023
