AND

Blaze International Beauty Academy, Pune, the second party, and represented herein by its Proprietor (herein referred to as "Second Party", Company which expression, unless excluded by or repugnant to the subject or context shall include its successors- in-office, administrators and assigns).

(First Party and Second Party are hereinafter jointly referred to as 'Parties' and individually as 'Party') as

WHEREAS:

- A. First party is a Teacher Education Institution named :
  - a. **School of Skill Development- Department of Beauty Therapy of Lewa Educational Union's Dr. Annasaheb G. D. Bendale Mahila Mahavidyalaya, Jalgaon**
- B. First Party & Second Party believe that collaboration and Co-Operation between themselves will promote more effective use of their resources and provide each of them with enhanced opportunities.
- C. The parties intent to co-operate and focus their efforts on co-operation within area of teacher orientation, skill education, joint organization of academic and social activities.
- D. Both parties, being legal entities in themselves desire to sign this MoU for advancing their mutual interests.
- E. Blaze International Beauty Academy, Pune the Second party is engaged in Students and teacher orientation, skill education, organization of academic activities.
- F. Blaze International Beauty Academy, Pune, the second party is operated by Dr. Smita S. Deo as a Proprietor of this Academy.
- G. Blaze International Beauty Academy, Pune is a leading and renowned academy in Pune City with lots of facilities related to beauty therapy.

**NOW, THEREFORE, IN CONSIDERATION OF THE MUTUAL PROMISES SET FORTH IN THIS MoU , THE PARTIES HERE TO AGREE AS FOLLOWS:**

#### CLAUSE 1

#### CO-OPERATION

1. Both parties are united by common interests and objectives, and they shall establish channels of communication and co-operation that will promote and advance their respective operations within the Institution and its related wings. The parties shall keep each other informed of potential opportunities and shall share all information that may be relevant to secure additional opportunities for one another in the field of sports.
2. First party and second party co-operation will facilitate effective utilization of the intellectual capabilities of the faculty of First party providing significant inputs to them in developing suitable teaching/ training systems, keeping in mind the needs of the industry, the Second Party.
3. The general terms of co-operation shall be governed by this MoU. The parties shall co-operate with each other and shall, as promptly as is reasonably practical, enter into all relevant agreements, deeds and documents (the 'Definitive Documents') as may be required to give effect to the actions contemplated in terms of this MoU. The term of Definitive





Documents, shall represent the entire understanding as to the subject matter hereof and shall supersede any prior understanding between the parties on the subject matter hereof.

## CLAUSE 2

### SCOPE OF THE MOU

1. The budding graduates from the institutions could play a key role in technological up-gradation, innovation and competitiveness of an industry. Both parties believe that close co-operation between the two would be of major benefit to the student community to enhance their skills and knowledge in the Beauty Industry.
2. **Training & Visits:** Interaction between parties will give and insight in to the latest developments / requirements of the industries; the second party to permit the faculty and students of the First party to visit various events and also involve in training programs. The training and exposure especially in the Beauty Industry provided to students and faculty through this association will build confidence and prepare the students to have a smooth transition from academic to working career. The Second Party will provide its Labs/ Workshops/ Beauty Expo for the hands-on training of the Faculty and students enrolled with the First Party.
3. **Research and Development:** Both Parties have agreed to carry out the joint research activities in the Beauty Industry.
4. **Skill Development Programs:** Second Party to train the students of First Party on the emerging technologies especially in the field of Beauty in order to bridge the skill gap and make them industry ready.
5. **Guest Lectures:** Second Party to extend the necessary support to deliver guest lecture's especially in the field of Beauty to the students of the first party on the technology trends and in house requirements.
6. **Faculty Development Programs:** Second Party to train the Faculties of First Party for imparting training especially in the field of Beauty as per the requirement considering the National standards in concerned sector, if available.
7. Both parties to obtain all internal approvals, consents, permissions and licenses of whatsoever nature required for offering the programs on the terms specified herein.
8. There is no financial commitment on the part of **School of Skill Development-Department of Beauty Therapy of Lewa Educational Union's Dr. Annasaheb G. D. Bendale Mahila Mahavidyalaya, Jalgaon**, the First Party to take up any program mentioned in the MoU. If there is any financial consideration, it will be dealt separately.

## CLAUSE 3

### INTELLECTUAL PROPERTY

1. Nothing contained in this MoU shall, by express grant, implication, Estoppels or otherwise, create in either Party any right, title, interest, or license in or to the intellectual property (including but not limited to know-how, inventions, patents, copy rights and designs) of the other party.

## CLAUSE 4

### VALIDITY

1. The validity of this agreement is from academic year 2021-22 to 2025-26.
2. Both parties may terminate this MoU upon 30 calendar Day's notice in writing. In the event of Termination, both parties have to discharge their obligations.





## CLAUSE 5


### RELATIONSHIP BETWEEN THE PARTIES




