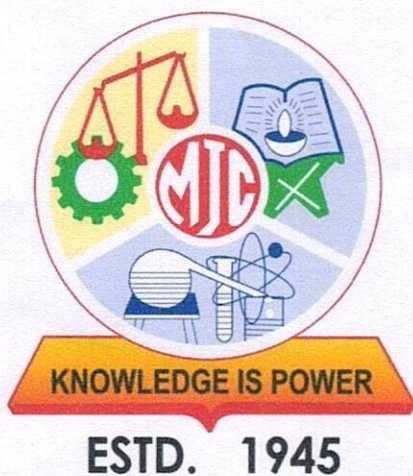

MEMORANDUM OF UNDERSTANDING (MoU)

Bendale Mahila Mahavidyalaya, Jalgaon) desire to develop academic exchange and cooperation in education and research between the two institutes and have agreed to sign and enter into MoU as follows:-

1. Objectives:-

- a. To provide a common forum for exchange of ideas and views regarding designing and / or execution of curriculum / programmes and research activities in the following broad areas.
 - i. Chemical Sciences
 - ii. Physical Sciences
 - iii. Biological Sciences
 - iv. Geography

- b. To use and share Libraries, database, documentation and instrumental and related-infrastructure facilities of each other.
- c. To exchange information and arrange joint Seminars / Workshops / Conferences.

2. Activities and Programmes:-

The institutions based upon the principle of respect for each others' independence and of mutual benefit, will carry out the following activities.

- i. Exchange of publications and information.
- ii. Joint Research Activities.
- iii. Exchange of faculty as visiting lectures.
- iv. Exchange of Botanical / Zoological Specimens / Class Work Materials/Permanent slides etc.
- v. Joint Excursion Tours.
- vi. Exchange of students.

3. Formulation of Plan:-

In order to carry out the above activities, detailed plans shall be formulated after consultation between the two colleges from time to time, depending on the nature and need of specific activity, availability of funds and convenience of both the colleges.

4. Financial terms and mode of payment, if any

The requirement of funds of these activities /programmes shall be work and through mutual consent between K. C. E. Society's Moolji Jaitha College, Jalgaon and Dr. Annasaheb G. D. Bendale Mahila Mahavidyalaya, Jalgaon.

K. C. E. Society's Moolji Jaitha College, Jalgaon and the Dr. Annasaheb G. D. Bendale Mahila Mahavidyalaya, Jalgaon shall not demand any monetary charges from each other for the use of technology and know-how development for their own internal use for the purpose of teaching training, research and development.

5. Dissemination of data and information-

The K. C. E. Society's Moolji Jaitha College, Jalgaon and the Dr. Annasaheb G. D. Bendale Mahila Mahavidyalaya, Jalgaon shall work out the modalities for dissemination of research data of Joint Research Projects to any third party keeping in mind the mutual academic interest. However, both parties shall fulfill their obligation of disseminating the data to national databanks, as required by the - concerned funding agencies.

6. Co-ordination committee:--

A Joint Co-ordination Committee for smooth and effective execution of activities and programmes under this MoU may be formed by mutual consent.


