Respected Sir,

At the outset we welcome the revised draft for "Conferment of Autonomous status upon colleges and measures for maintenance of standards in Autonomous Colleges".

While going through the revised guidelines, we found that the changes made therein are worth for speeding up the process of conferment of Autonomous status, however we would like to comment on one point which is missing in the draft and we feel, it is important. Comment:

In the revised guidelines point no.11 of previous guidelines, pertaining to "financial assistance and other related provisions" is missing. This indicates that in the new draft there is no such provision. If the financial provision is removed that would be very unfortunate. Because when we change the status of the college from Affiliated to Autonomous, major reforms are required to be made, right from Admissions to Examination and other academic activities. Funding is needed to bring about these changes effectively along with ICT support.



A talk on 'College Autonomy' by Dr. Anant Harkal


